The Honorable Omar Hernández is Senior Judge at the Department of Industrial Accidents (DIA) and was first appointed as an Administrative Judge in 2003. He was honored in 2012 by the MA Academy of Trial Attorneys for his years of outstanding public service both as an attorney and a judge at the DIA. After earning degrees from Cornell University and Suffolk University School of Law, he worked for Attorney Paul Gargano and then moved to Rainer & Rainer in Boston, handling workers' compensation claims. In 1994, he became an attorney in the Workers' Compensation Litigation Unit for the MA Human Resources Division, defending workers' compensation cases filed against state agencies. He was named Deputy General Counsel in 2000.

Laura Parsons, WCLA, FCLA, is Director of Claim for A.I.M. Mutual. She has held positions as Claim Technical Director,
