Jan. 6, 2021: COVID-19 COMMUNITY PRESENTATION

Other standards and guidelines such as those published by the NFPA, ASTM and AIHA will be discussed. Case studies drawn from Michael's many years of confined space experience will be highlighted in this session. Specific topics covered include confined space classifications, management of change, risk assessment, testing, training and rescue.

Jan. 20, 2021: TECHNOLOGIES TO IMPROVE WORKPLACE SAFETY AND OSHA MYTH BUSTERS

Rapid innovation in technology is influencing every corner of business operations—and workplace safety is no exception. Advances in PPE, robotics, data analytics, smartphones, video, and telecommunications are enabling employers to improve workplace safety in a variety of ways, such as better monitoring employees' health, reducing physical stress, and keeping personnel out of harm's way. In addition to protecting workers, safety technology can help boost employee morale, reduce turnover, and control business insurance costs. This presentation will attempt to separate truth from urban legend of OSHA requirements. While the presentation may have some entertainment value, it also teaches us that some of the stories we have heard for years just aren't true.

January 27, 2021: INDUSTRIAL VENTILATION

Industrial Ventilation and general HVAC ventilation are not the same thing. In our working world, there is a need to keep our breathing air as clean as possible and that requires the removal of many different types of air contaminants. We rely on our ventilation systems to do that and we must understand that just because we have a vent hood, it does not mean our workers are safe from the contaminants. This presentation is designed to provide you with some basic rules for good industrial ventilation. It is not calculation intense and not going to make you a ventilation
